The encyclopedia, usually composed of many volumes, is divided into several alphabetically ordered entries. Each author explains in a concise but precise manner the argument that each entry identifies. The consultation of an encyclopedia entry is the simplest manner to immediately get a general overview of the investigated issue.

It is important to read carefully the bibliography seated at the end of each entry.

The basic work is continuously updated.

The dictionary is based on a grid of entries.

Each entry is accompanied by a short analysis of the subject (a-d).

Sometimes the dictionary provides first information regarding the meaning of legal terms (b-c).

In other cases the legal terms and the corresponding foreigner legal terms (with a short illustration) are juxtaposed (e).

REPertoire OF THE ITALIAN FORUM

The ANNUAL REPertoire OF THE ITALIAN FORUM is one of the most accurate and complete repertoires that are currently available on the market.

The Repertoire is a collection of:

- Titles of laws published in the Gazzetta Ufficiale
- Bibliographical titles from all legal journals published in Italy (listed at the beginning of the volume)
- Jurisprudence maxims taken from journals or, if unpublished, from the Massimario in the year of reference

These data are divided into homogeneous groups called "ENTRIES", arranged in alphabetical order and progressively numbered.

The research of the entry is facilitated by the INDEX OF ENTRIES.

In addition to the INDEX OF ENTRIES, there are other INDICES:

- Fixed INDEX of items
- Fixed INDEX of laws and decrees
- Variable INDEX of articles of Constitution, Codes and Laws
- INDEX of decisions
- INDEX of authors
- INDEX of parties

To use the Repertoire, it is firstly necessary to identify the entry which refers to the documents needed to solve the investigated issue.

The texts of the materials are not reproduced in the Repertoire; indeed there are only the data identifiers and publication details of the volume or of the magazine (if containing the entire document)

Each entry contains:

- a) Normative Acts: the type of act, the date of its adoption, the number (if appropriate) and the title
- b) Doctrinal Materials: the author, the title of the work, the title of the magazine where it is published and / or the title of the monograph
- c) Jurisprudence: the issuing judicial body, the date of the ruling, the number or name of the parties (if appropriate), the maxims and the magazine in which it is published

In addition, THE REPERTOIRE OF THE ITALIAN FORUM contains, organized in alphabetically ordered ENTRIES:

- The indication of the current laws, annually updated
- The indication of the monographs and other legal works, as well as articles and notes published by specialized magazines, related to the year of reference
- The maxims of all the sentences published in the magazines in the year of reference or in the Massimario

THE REPERTOIRE'S ENTRIES, whose denomination is taken from the legislative terminology and from the terminology currently used in practice, are divided into:

- OPEN, regarding the relevant bibliography and jurisprudence.

They are listed in the appropriate index and identified by a progressive number: **ENTRY ADOPTION AND ASSIGNMENT [0160]**

- CLOSED OR REFERENCES, they have the function of facilitating the research by referring to open entries

In addition, there are often some references under the open and closed entries:

- FIXED REFERENCES (fixed because they are constant in every edition of the Repertoire) specify the content of open entries and generally indicate a connection between voices. **(ADOPTION AND ASSIGNMENT [0160] - fixed reference FILIATION)**

- VARIABLE REFERENCES (they may or may not appear in the Repertoire, and they are printed in italics) **(ADOPTION AND ASSIGNMENT [0160] - variable reference FOREIGNER)**
